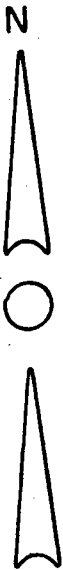
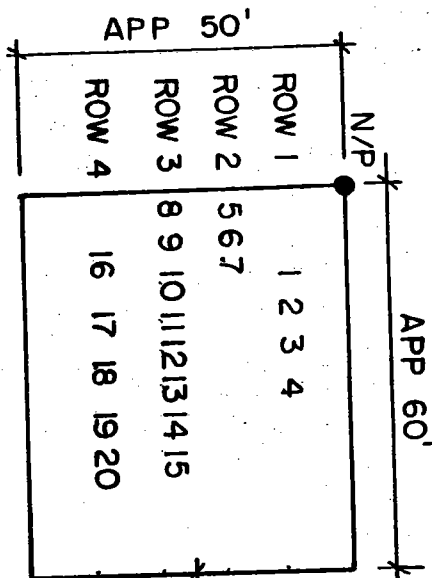
LOCATION DISINTERMENT MAP

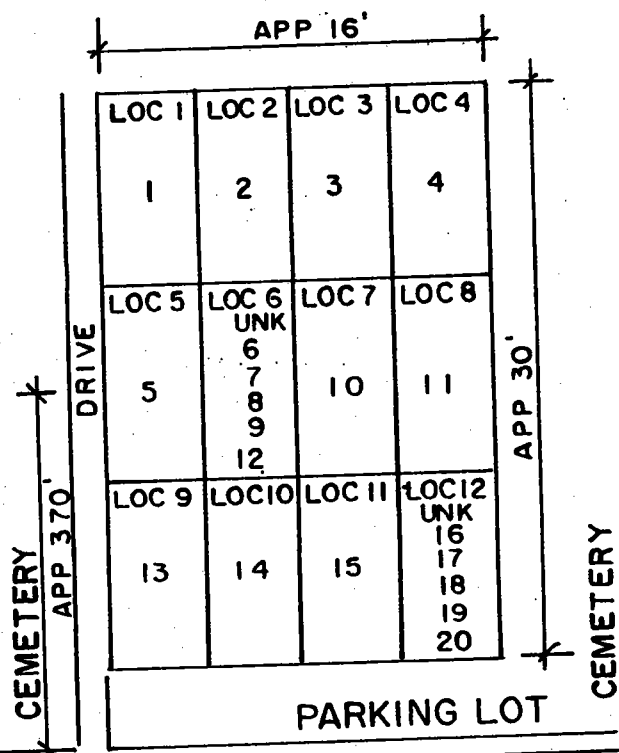
